Guidelines for Submission

The manuscript should be typewritten (Times New Roman -12 font size), double -spaced, with one and half inch margin on all sides. The title of the manuscript should be clear and precise. The pages should be numbered serially throughout the paper. Illustrations and other materials reproduced from other publications must be properly credited.

Categories of Manuscripts

Research Article (4500 - 6000 words) - should include in -depth analysis and recent findings. It should contain following sections (a) Abstract (100 -150 words), (b) Key words (not more than 5, listed alphabetically), (c) Acknowledgement (if any). Where possible, the research article may follow the given structure: Introduction, Background, Review of Literature, Method , Major Findings and Discussion.

Review Article (5000-6000 words) – is expected to any academic piece or related policy relevant to the diverse settings of the discipline.

Book Review (1000-1200 words) – should contain academic review of any book or report recently published in the relevant research or practice settings.

References

In APA style (6th edition), in-text citations are placed within sentences and paragraphs so that it is clear what information is being quoted or paraphrased and whose information is being cited.

Reference List/Bibliography

References cited in the text of a research paper must appear in a Reference List or bibliography. This list provides the information necessary to identify and verify each source.

Tables and Figures

All tables must be numbered consecutively in Arabic numerals in the order of appearance in the text. A short descriptive title should appear above each table with a clear legend, with footnotes, where needed, suitably identified below. All figures should be numbered consecutively in Arabic numerals in the order of appearance in the text.

Submission of Article

A soft copy of the manuscript, along with a cover letter, plagiarism check report and copyright for m should also be sent to the addresses provided for the purpose.

The journal is multi -disciplinary; therefore research and review papers of general significance that are written clearly and are well organized will be given preference. Manuscripts submitted that do not adhere to the prescribed format will be rejected.
