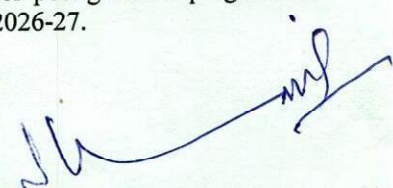

The board approved the syllabus of the existing theory courses and allowed the modifications/changes to the tune of more than 20 percent. It was also resolved to introduce the two streams of course one concentrating on research and the other on course work only. Furthermore, guidelines for field work, grand viva and internal assessment were also approved after necessary inputs from the members. Lastly, the syllabus and its guidelines for the subject of social work for post-graduate programme (PG) were approved to be effective from the next academic session i.e., 2026-27.

Agenda: To examine the Draft Curriculum and Credit Framework for Post Graduate programmes notified by UGC.

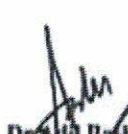
